Contra Costa Hills Club Annual Meeting Minutes

March 10, 2024, Oakland

Lakeside Garden Center

The day began at 10:15 A.M. About twenty hardy members hiked around the three plus mile Lake with vigor and enthusiasm, especially considering we all had one hour less sleep. We returned to the garden center to eat bag lunches and to enjoy refreshments generously provided by the Board members.

At noon, **Guest Speaker Joe O'Connor** was introduced by Roberta O'Grady.

I met Mr. O'Connor when he moved into my residence, Cardinal Point. I noted his photographs of nature he put outside his door a small display of recent photos of plant and animal life in Alameda and along the estuary. He has made presentations to our community on his studies of nature.

Mr. O' Connor grew up near Boston, Massachusetts. His degree is from the state University of New York in Ecology and Physiology. He enjoys, sailing, hiking, cross country skiing, fishing and winter camping. During college he had job as a caretaker on a 5,000-acre nature preserve.

He was in the Department of environmental and health Sciences at New York University. His studies were on the life in Chesapeake Bay, the Hudson River and Atlantic Ocean. At this time he lived very near the Appalachian Trail and did lots of hiking.

Mr. O'Connor spoke on 'And What is That Based On - Geological Wonders Surrounding Us in the Bay Area.'

His talk began with a reference to Albert Wegener, a German, who wrote on the origins of the continents and oceans, 1912- 1915 and introduced the concept of continental drift. He also briefly described the work of Henry Hess, an American, who described the oceanic mountain ranges or mid-ocean ridges which result in drift of continents. He showed us the 7 major tectonic plates. Their movement leads to the formation of mountains and earthquakes and volcanoes. We had interesting views of the major types of rock found in the Bay Area. These are 1) Sandstone - a sedimentary rock formed from compacted grains of sand; 2) Grey Wacke - volcanic rock fragments, hard dark sandstone with grains of quartz in compact hard clay; 3) Serpentenite - a metamorphic rock composed of serpentine minerals; 4) Chert - sedimentary rock composed of microcrystalline quartz; 5) Basalt - igneous rock formed by the rapid cooling of lava, the oldest type of rock. He pointed out where we can view these rocks on our hikes in the local hills, especially in the parks of San Francisco. Learning about the geology of our Bay Area home is a great opportunity to enhance our enjoyment of hiking.

Attendance: 46 members were in attendance, formulating a quorum.

Business Meeting – President Stew Perlman called the meeting due to order at 1:10pm.

President's Message: On behalf of the Board of Directors, I want to thank those members who kindly and responsibly attended the 2024 CCHC Annual Meeting this past Sunday at the Lakeside Park Garden Center, Lake Merritt, Oakland.
